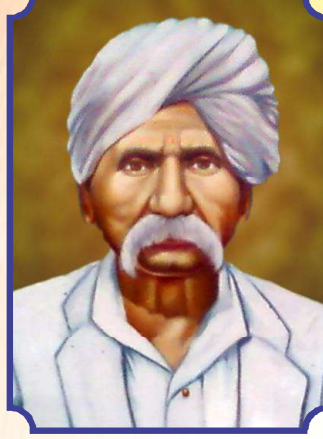

Three/Four Years Under Graduate Programmes with Honours or Honours with research offered by the college for Academic year 2024-25 under NEP 2020.

Shri. Dnyaneshwar Maskuji Burungale Science and Arts College is affiliated to Sant Gadge Baba Amravati University, Amravati. The UGC has revised the CBCS and developed a new Curriculum and Credit Framework (CCF) for undergraduate and post graduate programmes. New Education Policy (NEP) is being implemented by the Indian government's ministry of education (MoE) beginning with the 2023-24 academic year and Sant Gadge Baba Amravati University is implementing NEP - 2020 from an academic session 2024-2025 to undergraduate courses in the jurisdiction of Sant Gadge Baba Amravati University region.

NEP Implementation in First Phase:

Applicability: This scheme shall be applicable to the undergraduate Programmes B.A., B.Sc., B.Com., B.B.A., B.C.A., B.P.E.S., B.Sc. (Home Science), and all Non-AICTE Professional UG Degree Programmes in the faculty of Science & Technology (Science Group), Commerce & Management, Humanities and Interdisciplinary studies. The **Department Specific Core (DSC)** concept shall be implemented at non-autonomous affiliated colleges for the above mentioned programme.

Objective: The structure of the Three/Four - year Bachelor's Degree Programme alters the opportunity to students to experience the full range of holistic and multi-disciplinary education in addition to a focus on the chosen Major and Minor as per their choices and the feasibility of exploring learning abilities.

Explanation:

- (a) **Major (Core) Subject 60 - 64 Credits:** It is the discipline or subject of main focus and the degree will be awarded in that discipline/Subject. For example: B.Sc. (Botany), B.Com. (E-Accounting and Taxation), B.A. (Political Science), B.Sc. (Home Science - Food and Nutrition), etc.

Students shall have to secure a minimum 50% of total Credits through Core Courses (mandatory courses, electives, vocational courses, Major Specific IKS, Internship/ Field Projects/ Apprenticeship/ Community Engagement Projects, Seminars, and Group Discussion).

- (b) **Minor Subject 18-20 Credits:** Minor subjects will be subjects focusing on multidisciplinary education as expected in the NEP-2020. The student choosing department specific core (DSC) may choose Minor from same faculty or faculty unrelated to the Major, but something that complements the Major. For example,

student opting Botany as a Major, may choose, Minor of Chemistry/ Zoology/ Environmental Science/Microbiology as Minor; student opting E-Accounting and Taxation as Major can opt Minor of Business Dynamics/ Business Gimmicks / Business Analytics / E- Accounting & Taxation Business Dynamics; student opting Political Science as Major can opt Minor of Sociology, English Language, Geography; students opting Food and Nutrition of Home Science as Major can opt Minor of Textile and Clothing; etc.

- (c) **Generic/Open Elective Course (GE/OE) 10-12 Credits:** A student is required to select an '**Generic/Open Elective Course**' from the 'Generic/Open Elective Course Basket' of any Programme offered by the university in any faculty before filling the examination form for the semester concerned. Such an 'Generic/Open Elective Course' cannot be selected from the subjects chosen by a student as 'Major' and 'Minor' subjects.
- (d) **Vocational and Skill Enhancement Courses (VSEC) 14 - 16 Credits:**
- i) **Vocational Skill Course (VSC) 8-10 Credits:** Wherever applicable vocational courses will include skills based on advanced laboratory practical of Major. A student is required to successfully complete the 'VOCATIONAL SKILL COURSE' as mentioned in this scheme of examination. This course must be a course corresponding to the 'MAJOR' subject selected by a student.
- ii) **Skill Enhancement Course (SEC) - 6 Credits:** A student is required to select a 'SKILL ENHANCEMENT COURSE' from the basket provided by the university for this purpose.
- (e) **Ability Enhancement Courses (AEC), Indian Knowledge System (IKS) and Value Education Courses (VEC) - 14 Credits:**
- i) **Ability Enhancement Course (AEC)- 08 Credits:** A student is required to undergo and successfully complete the 'ABILITY ENHANCEMENT COURSE' as English for 04 Credits and Modern Indian Language for 04 Credits.
- ii) **Generic IKS Course - 02 Credit:** These are expected to contain basic knowledge of the Indian Knowledge System (IKS). It should contain introductory information to the IKS. The student should be able to acquire a basic knowledge after completion of the course.

(Subject Specific IKS Course: This is 2 Credit courses should contain advanced information pertaining to the subject as these will be considered as a part of the Major Credit. The student should have completed the Generic level as a prerequisite before enrolling in the discipline related course)

iii) **Value Education Courses (VEC) - 04 Credits:** Value Education Courses (VEC) are such as Understanding India, Environmental Science/Education, and Digital and Technological Solutions. A student is required to undergo and successfully complete the VEC.

(f) **Field Projects/ Internship/ Apprenticeship/ Community Engagement and Service corresponding to the Major (Core) Subject, Co-curricular Courses (CC) and Research Project:**

These verticals of Major are to be completed by the student under the supervision of mentor faculty as per Teaching Learning Scheme.

The program will include Four-Year Multidisciplinary Degree Programme with Multiple Entry and Exit Options as given below:

Enrollment and Registration of Students on ABC :

- * **Creation of ABC ID:** Credits awarded to a student from one program from an institution may be transferred/ redeemed by another institution upon the students consent through ABC. Therefore, it is essential to all students to enroll on ABC, Create ABC ID and share ABC ID with academic institution where he/she admitted.
- * **Credit Transfer Mechanism:** Credit Transfer Mechanism comprising of Credit Accumulation, Credit Recognition, Credit Redemption and Credit Transfer shall be as prescribed.

Examination and Assessment Process:

- i) The basic principle of the Credit framework is that Credits are a function of the successful completion of a program of study/ vocational education/ training and assessment. No Credit can be earned by the student unless the student is assessed for the achievement of the desired competencies and outcome of a program.
- ii) Exit options are provided with Certificate, Diploma and Basic Bachelor's degrees to the students at the end of the second, fourth and sixth semesters of a Four Years Multidisciplinary Degree Programme. Students will receive a Bachelor's degree with Honors/ Research on successfully completing of all eight semesters of the UG Program either at a stretch or with opted exits and reentries.
- iii) For the smooth success of four-year degree programme with multiple entry and exit systems, the examination mode should be based on the combination of innovative trends in formative (informal and formal tests administered during the learning process) and summative (evaluation of students learning at the end of an instructional unit) examination modes in line with the UGC Report on 'Evaluation Reforms in Higher Educational Institutions (2019).

Examination, Evaluation and Assessment Scheme

The total marks for each Course shall be based on Continuous Assessment and Semester End Examination. Each theory course of Major, Minor, GE/OE, AEC, IKS, VEC prepared by the respective Board of Studies shall be evaluated as per the scheme as mentioned in the table given below:

Continuous Assessment Tests (CAT)

For internal assessment, the Continuous Assessment Tests (CAT) shall be conducted as under:

- i) Three CAT each of 8 / 10 Marks (Theory) as applicable and 10 Marks (Practical).
- * First on completion of 25% Syllabus of the course or on completion of 25 teaching days,
- * Second on completion of 50% Syllabus of the course or on completion of 50 teaching days,
- * Third on completion of 75% Syllabus of the course or on completion of 75 teaching days.
- ii) Each concurrent assessment (CAT-I, II & III) will be mapped to relevant Course Learning Outcome.
- iii) Total Performance in CAT (i.e.40 %) shall be based on the best two out of three in CAT examinations
- iv) Internal assessment shall be carried out by the respective course teacher by choosing variety of assessment tools/methods such as class test, record book, seminar, case study, field work, mini project work, quiz or any innovative method, which may be deemed to be appropriate for assessing the relevant course outcome.

Conduction of the Examination:

As per the scheme of teaching, learning, examination and evaluation, theory/practical examinations of Semester-I, II, III, IV, V, VI, VII and VIII shall be conducted by the University (except for Internal Examinations as applicable) at the end of each semester.

7. General Information.

7.1 Admission Process

- a) The last date for submission of application form will be displayed on notice board and official website (www.sdmbc.ac.in) of the college.
- b) The students of reserve category and opting for any concession should fill the respective form before **31st Aug 2026** otherwise they have to pay full fees.
- c) The selected candidates will have to pay all fees within the prescribed date. In case a student does not deposit fees by that date, his/her admission shall be treated as cancelled.
- d) No certificate of any kind will be issued, unless deposition of full session fees.
- e) Enrollment:- All new admitted students will have to enroll themselves in the University. A prescribed form for this purpose will be supplied by the college in due course of time and date prescribed by the university. A fine of Rs. 100/- is imposed by the University if the enrolment form along with the enrolment fees not reached the University within the prescribed date.
- f) Admission will be provisional, subjected to the approval of the University and is liable to be cancelled at any time if the applicant has given false information or University enrolment is not given to him/her.
- g) The Principal may amend the admission rules at his discretion. The Principal's decision in all matter related to admission shall be final

7.2 Attendance

- 7.2.1 In order to qualify for University Examination, students must attend at least 75% lectures (including practical) delivered in each subject.
- 7.2.2 Students who fall short of the required attendance also do not qualify for any concession, such students will have to pay full fees.
- 7.2.3 Students whose attendance is less than 75 % will not be allowed for university examination.

7.3 College Examinations.

- 7.3.1 Semester Examination in the second week of October for odd semesters & second week of March for even semesters.
- 7.3.2 All unit tests (class Tests) will be conducted as per schedule notified by concerned teacher. All students will have to compulsory appear for the examinations. Students remaining absent from the above examination without prior permission shall be fined accordingly whereas students with persistently good performance in all the unit tests and annual terminal examination will be given incentive.

7.4 Student counselling Units.

7.4.1 Career guidance cell

The College has cell for guiding the student to choose their career, course of higher studies and for their personality development.

7.4.2 Teacher Counselling Scheme.

On joining the college each student is placed under the personal supervision and guidance of a teacher and keeps record of the student's progress and the activities.

- 7.5 College Magazine:**
College magazine "RIGVEDA" is run by editorial board consisting of members of staff and students who have a flair for writing. This gives an opportunity for self expression to the students in Marathi ,Hindi and English.
- 7.6 Cultural activities and Youth Festival:**
The college provides opportunities to talented students to participate in various cultural activities throughout the year and to participate in University Youth Festival.
- 7.7 Feedback mechanism.**
A significant involvement and cooperation of parents and students through a feedback mechanism is utmost necessary for the continuous improvement of college.
- Suggestion Box.**
A suggestion box is available near the office of the Principal. The students can avail this facility for giving positive suggestions and to solve their problems.
- 7.8 Games & Sports.**
The college encourages students to participate in various games and sports. We have facilities for Kabaddi, Kho-Kho, Volleyball, Cricket , Badminton etc.
- 7.8 a Physical Efficiency Test:**
All students are compulsorily required to attend the physical training classes. 75% attendance is necessary for Ist and IInd year students to appear for the annual PE test to be held in the month of January. Physical education department will notify the programmes, failure to appear shall be treated as indisciplinary action as per the university rules.
- 7.8 b Sports Day Celebration.**
This day celebration will be held in the month of December. The dates and schedule will be notified in due course of time.

8. DISCIPLINE

“Discipline and obedience are the dual keynotes to success. We expect our students to maintain the same.”

The following rules have been framed for maintenance of discipline for the students of this college

1. National anthem sung regularly in the college.
2. Students shall have to obey all the instructions of the Principal. The Students are answerable to him for their behaviour in general, both inside and outside the college campus. The names of students found violating the rules of the college administration or behaving in an undisciplined manner will be removed from the college. 3. Students should behave respectfully with all staff members and politely with their fellow students. Any act of disobedience improper and discourteous exchange of words or passing of indecent remarks specially on girl student is punishable offence and will be viewed seriously.
4. Students should make careful use of college books, room, furniture, fans, laboratory equipment and the college property in general. The cost of damage done to it would be recoverable from students either individually or collectively as the case may be.
5. Only special notices shall be read out in the classroom. Students therefore, should see the notice board daily and keep themselves well informed about the various notices that may be put up there from time to time.
6. No students shall directly send any information concerning the college for publication either to the press or elsewhere without prior approval and the necessary permission of the Principal. Further without prior permission, he/she should not approach the President or the C.D.C. Member except through the college Principal. Any breach of this rule may lead to outright expulsion of the student from the college.
7. The students should not roam in corridors during working hours of free classes, instead they should utilize the library, sport and internet facilities.
8. There is strictly prohibition on smoking and chewing the substances like tobacco, gutkha, pan etc. in the college campus.
9. There is strictly prohibition on drinking and carrying alcoholic substances in the campus.

The action will be taken on the points mentioned in the UGC Circular No. No. F. 1-9/2006 (CPP-II) October, 2006 and UGC letter No D. O. No. 1-9/2006(CPP-II)/ March.2013 dated 03 April 2013.

CIRCULAR

“The Cigarettes and other Tobacco Products (Prohibition of Advertisement and regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003” which came into effect from 1st May, 2004. contains certain provisions pertaining to educational institutions. In order to ensure effective implementation of these provisions of the Act, the Universities are requested to take necessary action on the following points:-

- 1 The ‘Boards’ as prescribed under the rules are to be displayed outside the premises of the University and its affiliated colleges, prominently stating that sale of cigarettes and tobacco products in an area with in a radius of 100 (one hundred) yards of the University is strictly prohibited and that such sale is an offence punishable with the fine which may extend to two hundred rupees;
- 2 Action has to be taken to sensitize the teaching and non-teaching staff of the University and its affiliated colleges on the issue so that the system is in place immediately.
- 3 The names of the persons authorized to ensure the implementation of this system may be duly notified
- 4 The shops, if any, selling cigarettes and other tobacco products around the University, are to be got removed immediately.

The copy of the Act and related O. Ms/Circulars have already been sent to the Education Secretary of your State/UT by the Ministry of Human Resource Development, Department of Education, New Delhi.

All the Universities and Deemed Universities are requested to take necessary action to ensure the implementation of the provisions of this Act

PUBLIC NOTICE

CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS

It is brought to the notice of the Institutions, students and other various stakeholders that ragging is a criminal offence and UGC has framed regulations, on curbing the menace of ragging in higher educational institution, in order to prohibit, prevent and eliminate the scourge of ragging. The regulations have been notified vide No. F. 1-16/2009 (CPP-II) dated 21.10.2009 and are available on UGC website www.ugc.ac.in.

The above mentioned regulations are mandatory and shall apply to all Universities established or incorporated by or under a Central Act, a Provincial Act or a State/Union Territory Act and all Institutions recognized by or affiliated to such

Universities and all Institutions deemed to be Universities under Section (3) of the UGC Act, 1956 with effect from 4th July, 2009 i.e. the date of its Publication in the official Gazette. All institutions are required to take necessary steps for its implementation in toto including the monitoring mechanism as per provisions provided in the above regulation and ensure its strict compliance. The following preventive measures for

Anti-Ragging should also be strictly followed:-

- 1) The Institutions may erect suitable hoardings/bill boards/banners in prominent places within the campus to exhort the students to prevent or not to indulge in ragging and also indicating therein the names of the officials and their telephone numbers to be contacted in case of ragging.
- 2) All Educational Institutions should form an Anti-Ragging-Committee and squads and dedicated cadre of wardens and professional counselors to ensure that the directions of Hon'ble Supreme Court of India and Justice Raghavan Committee recommendations are followed without exception.
- 3) An affidavit must be obtained from every Student, Parent/Guardian separately as per clause (m & n) of Regulation 6.2.
- 4) The Institution may also undertake other forms of campaign as it may consider appropriate for prevention of ragging.
- 5) UGC has uploaded a film on anti-ragging on its website. All universities and colleges are requested to download the same and give wide publicity amongst the students, before the start of the academic session. Besides, this may be constantly monitored during the entire period of the academic session.

Any violation of UGC regulations as cited above or if any Institution fails to take adequate steps to prevent ragging or act in accordance with these regulations or fails to punish perpetrators of incidents of ragging suitably, UGC shall call for punitive action against erring institutions.
